This operation, representing an activity of around €1 million in elastomer molding, aims to accelerate the development of Somocap and expand its portfolio of products.

Specializing in the molding of rubber, composite and technical plastic parts, Somocap is continuing its strategic development plan.

In 2023, the company which operates 3,000 m2 of production space which has become insufficient, launched into the construction of a second production site to ultimately double its production capacity. This project is accompanied of an ambitious commercial development plan aiming to achieve a turnover of \leq 8 million by 2028 compared to \leq 5.8 M \leq in 2023.
